The main goal of Alyssa's Hike for the Hearts is to support two separate issues involving immediate and eternal needs of families whose children have succumbed to sudden cardiac death caused by viral myocarditis. The first issue we address would be the "immediate" need of a child's physical heart. One of our objectives is to support research in the area of sudden cardiac death in children specifically caused by viral myocarditis. Currently we have assessed and believe that the research being conducted by Dr. Gerard Boyle at the Cleveland Clinic Children's Hospital is worthy of our support. Their main focus currently is investigating and studying the causes, distribution and control of Viral Myocarditis in the pediatric community. It is their desire to find and define the early symptoms of Viral myocarditis that patients might have when they go to emergency rooms. Part of the design of their studies will be a program to help increase awareness to local practitioners about what they should look for and when they should suspect a diagnosis of Viral Myocarditis.

The second issue we plan to address would be the eternal need of a child's heart. We plan to accomplish this by providing funds for camp scholarships for school aged children to attend Camp Carl, a ministry of The Chapel in Akron, Ohio. The eternal needs of children's hearts would be addressed by providing Christ-centered hope and healing through the ministry conducted at Camp Carl. Alyssa's Hike for the Hearts sends funds to the "Alyssa Ann Calaway Memorial Fund" at the Chapel where staff members of the church and camp decide upon the recipients of the scholarships.

Alyssa's Hike for the Hearts is a once a year hiking event that is attended by community members and friends who support our mission.
